1.2. Drugs and Alcohol Policy

Abuse of drugs and alcohol and its effects is one of the most significant social problems of today and increasing efforts are made to reduce the problem.

Working on board a ship there is one objective only in this respect: our ship or its equipment must not be operated by crewmembers impaired by drugs or alcohol (impairment shall in the connection be benefited as a blood alcohol content of 40 mg/100ml or greater). Any breach of this objective will result in immediate dismissal of the crewmember in question.

To insure that the above objective is fulfilled, delivery of alcohol and legitimate drugs must be controlled so that all the crew members are able to respond at any time to an emergency situation and B&I shipping and projects hereby instruct the crew of all of their equipment as follows:

- 4 hours (4) abstinence is required prior to watch-keeping or duty.
- Misuse of legitimate drugs is prohibited.
- Use, possession, distribution or sale of illicit or non-prescribed controlled drugs on board the ship is prohibited.
- Special attention is to be given to warnings on legitimate prescribed and over-the-counter medicine.

In order to be able to prove to the third party the above objective is fulfilled and the above instruction is followed B&I shipping and projects can test and screen the crewmembers for drugs and/or alcohol abuse during routine medical examinations as well as unannounced testing. Tests are to be carried out by "recognized authority" or by the master of the vessel in case of abuse suspicion.

1.3. Smoking policy

As required by the law and occupational Health Regulations, it is forbidden to smoke at the workplace. This means that it is not allowed to smoke in all enclosed areas of B&I shipping and Projects. This concerns not only all office spaces, but also all closed spaces on board, the work centers and cars which are brought to you by B&I shipping and projects. During working hours, the smoking breaks should be kept to a minimum.

If the room, car, etc. needs to be cleaned because of nuisance, B&I shipping
